2 Proposal to appoint Ms. Anjana Harve as member of the Supervisory Board

In line with articles 21 and 22 of the Articles of Association, the Supervisory Board proposes to appoint Ms. Anjana Harve as member of the Supervisory Board, for the period starting on October 28, 2024, and ending after the Annual General Meeting of Shareholders to be held in 2029.

The Supervisory Board currently consists of six members, as Ms. Jeanette Horan retired at the end of the general meeting held on May 8, 2024. Over the past months the company has conducted a search for a new member of the Supervisory Board to bring the number of Supervisory Board members back to seven, in line with the profile. The Supervisory Board is pleased to announce the nomination of Ms. Anjana Harve as new member of the Supervisory Board, in view of her knowledge of technology infrastructure, cybersecurity and cultural transformation, and broad experience in global companies in amongst other the healthcare space.

She is EVP and Chief Information Officer with BJ's Wholesale Club Holdings, Inc., a leading warehouse club operator in the United States of America.
