

### MODERN SLAVERY STATEMENT

Wolters Kluwer (UK) Limited (a private limited company incorporated in England & Wales with company registration 450650, whose registered office address is at 145 London Road, Kingston upon Thames, KT2 6SR, UK) ("we", "us", "our" in context) makes this statement under the Modern Slavery Act 2015 (the "Act") for the financial year ending 31 December 2024. This statement describes the steps taken to prevent modern slavery in our business and supply chain.

Modern slavery is a crime and a violation of fundamental human rights. Modern slavery takes various forms, such as slavery, servitude, forced and compulsory labour and human trafficking, all of which have in common the deprivation of a person's liberty by another in order to exploit them for personal or commercial gain.

We are proud of the steps we have taken to combat slavery and human trafficking to date.

# DUE DILIGENCE PROCESSES FOR SLAVERY AND HUMAN TRAFFICKING

We have zero tolerance to modern slavery and human trafficking.

As part of our initiative to identify and mitigate risk we have in place systems to:

- o Identify and assess potential risk areas in our supply chains with the help of the group, internal audit, human resources and legal.
- o Mitigate the risk of modern slavery and human trafficking occurring in our supply chains.
- Protect whistleblowers.

We believe our due diligence processes take a proportionate approach to the identified modern slavery risk.



## SUPPLIER ADHERENCE TO OUR VALUES AND ETHICS

Wolters Kluwer continually seeks ways to identify, assess, prevent or mitigate adverse human rights impacts and encourages the same behaviour from its partners, vendors and suppliers through its Supplier Code of Conduct.

The Wolters Kluwer Supplier Code of Conduct prohibits any supplier from directly or indirectly using, participating in, or benefiting from any form of human trafficking, slavery, servitude or any forced, bonded, prison, military or compulsory labour or similar coercion or exploitation. We expect suppliers to have remediation procedures to assist any worker found to be subjected to any form of involuntary labour, including human trafficking. Suppliers are required to support and respect internationally recognized human rights in dealing with their stakeholders at large, namely their employees, clients, suppliers, shareholders, and communities.

Wolters Kluwer expects suppliers (and anyone acting on suppliers' behalf) to implement management systems, including policies, procedures, objectives, training, and self-monitoring, to ensure compliance with the standards described in the Wolters Kluwer Supplier Code of Conduct or to have established and committed to an equivalent standard as well as with local laws and regulations.

Wolters Kluwer supports the principles of the United Nations Universal Declaration of Human Rights, the United Nations Guiding Principles on Business and Human Rights, the OECD guidelines for Multinational Enterprises, the Core Labor Standards of the International Labor Organization. Wolters Kluwer is a signatory of United Nations Global Compact and the United Nations Women Empowerment Principles and is committed to aligning with these respective principles.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our modern slavery statement for the financial year ending 31 December 2024. This statement was approved by the Board of Directors of the Company on 15 September 2025.
