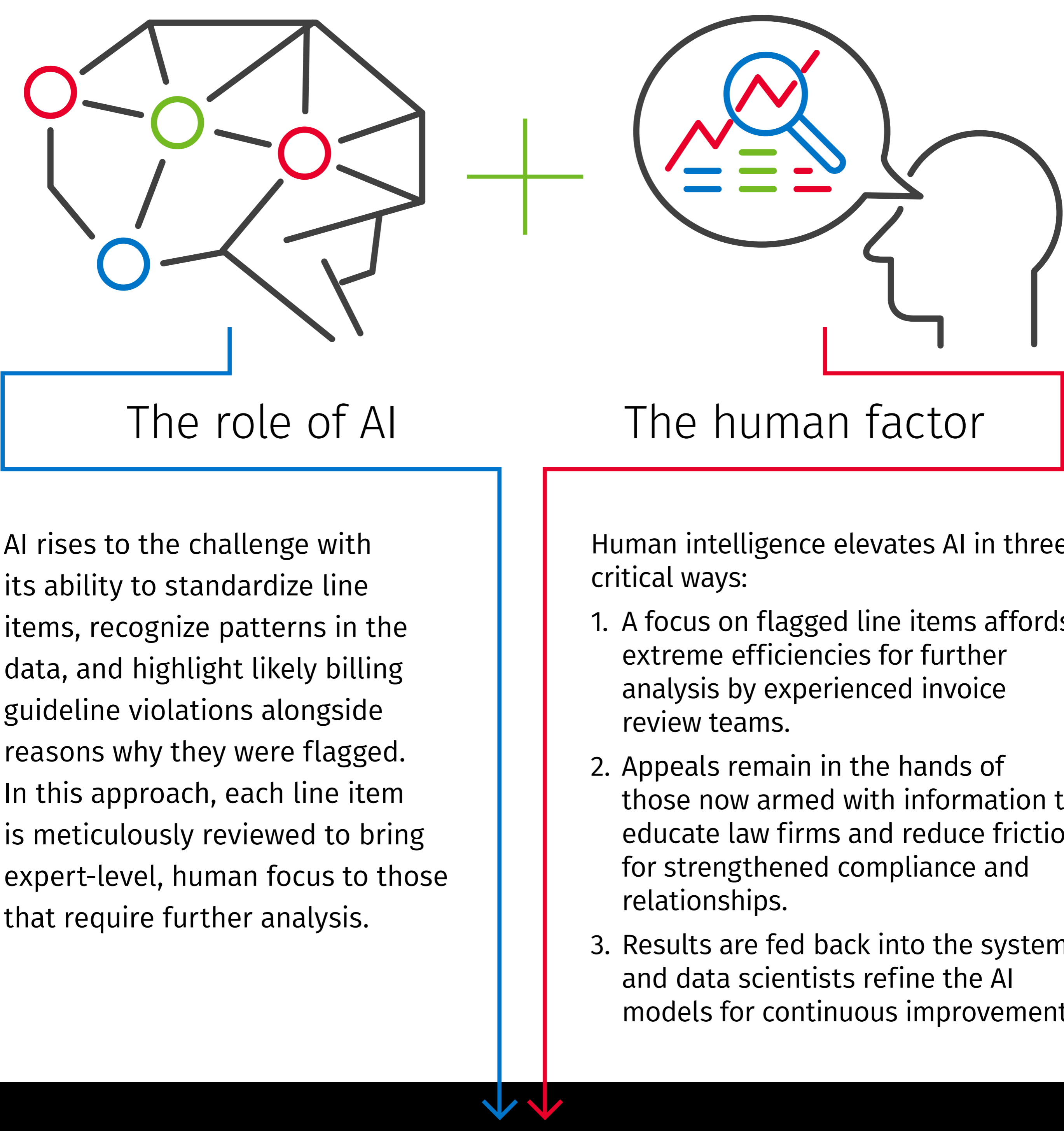

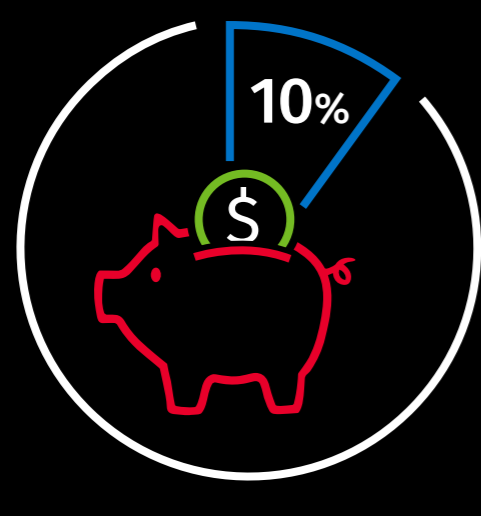
Cost control is a top priority, though complex billing guidelines and operational efficiencies contribute to the cost of attorneys performing mundane tasks.

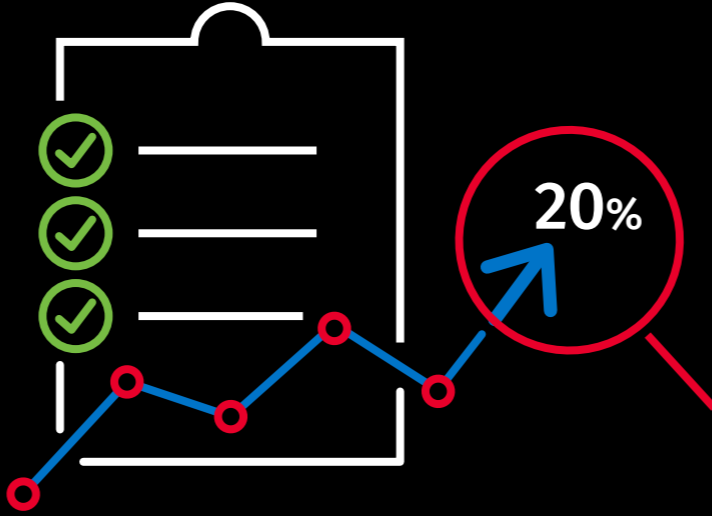

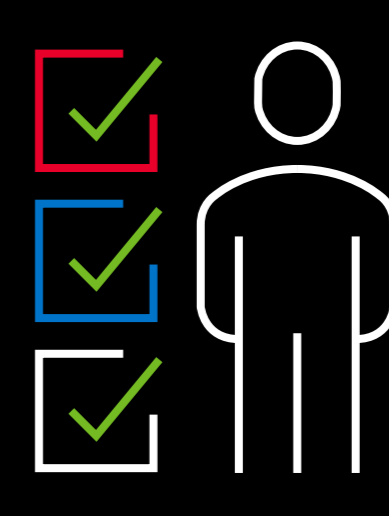
