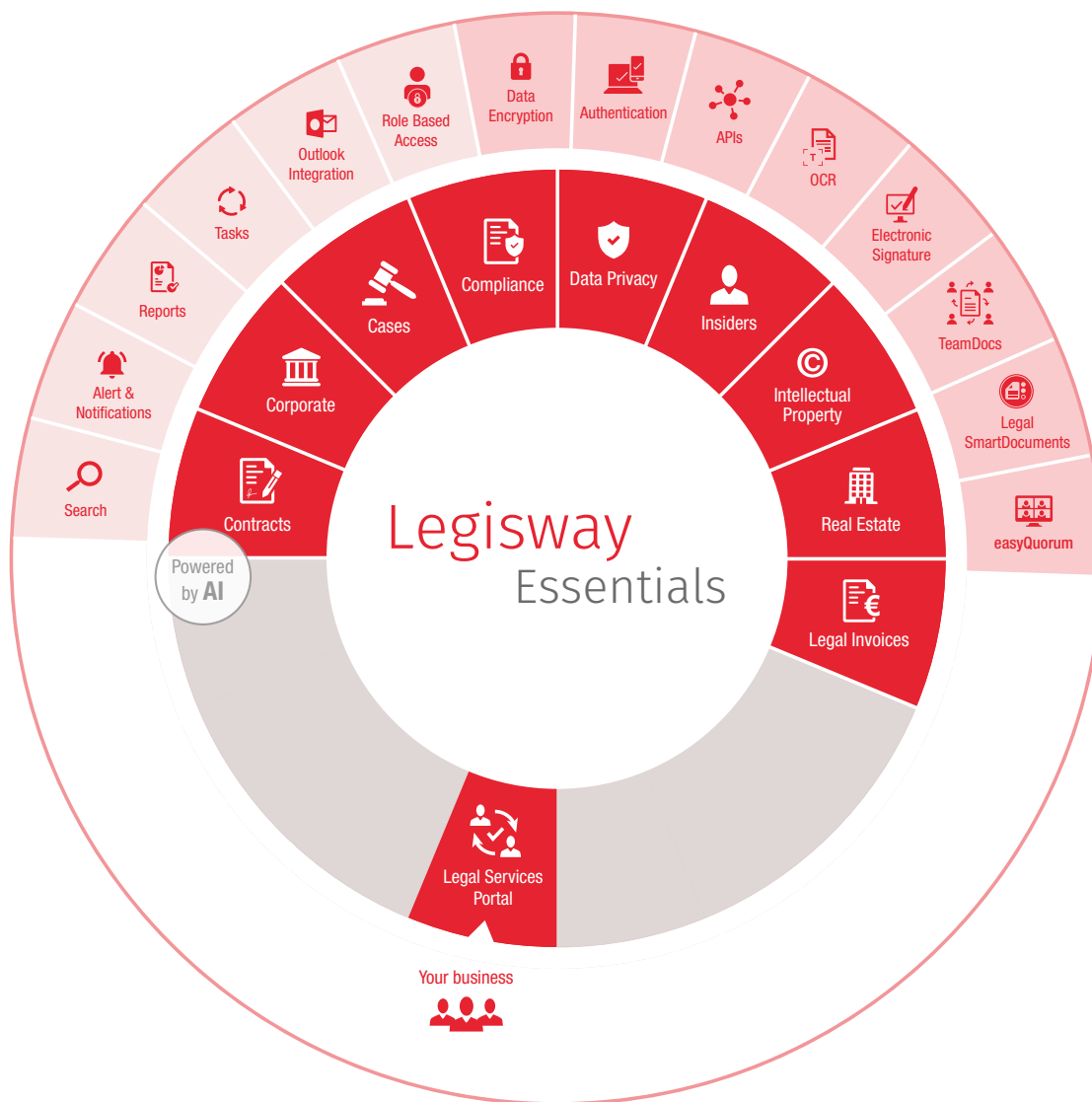

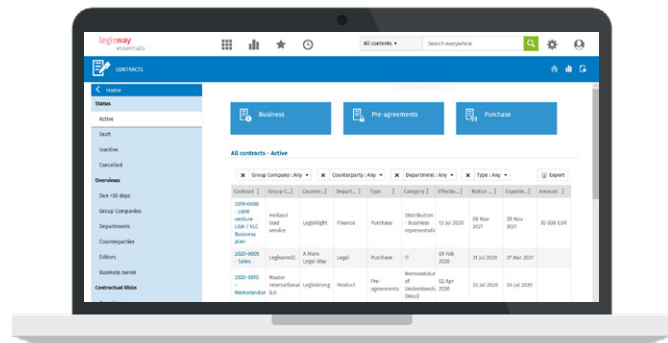

### Contracts
