Many state laws require that corporations and limited liability companies keep certain types of information. This chart provides an overview of some of the more common statutorily prescribed records to be kept by the entity. The individual state statutes should be consulted for more information such as where the records must be kept, the format, for how long they must be kept, and for any additional records that may be required beyond those listed in the charts. The states' record inspection requirements should also be consulted although they are not covered by this chart. These statutes set forth which records must be provided to shareholders or members upon their request or demand without actually specifying that these records must be kept or maintained.
