RULES FOR SUBMISSION OF PUBLICATION MATERIALS

- The editorial office kindly informs that no royalties are paid for articles published in the "Public Law Review".
- The editorial office kindly informs that only materials generally not exceeding 40,000 characters will be accepted, sent by e-mail to the e-mail address of the editorial secretary: andrzej.adamczyk@ujk.edu.pl.
- The article or review should be accompanied by an **abstract in Polish and English** (about 1,000 characters each) along with **keywords** (**in Polish and English**) and the **title in English**, as well as a **bibliography attached** (sorted alphabetically according to the authors' names) and the **ORCID number**. Please also provide information on the sources of funding (e.g. a grant), and in the case of **co-authorship please provide the percentage of contribution to the publication by each of the authors**. Abstracts of published papers are available online in the international database "The Central European Journal of Social Sciences and Humanities", http://cejsh.icm.edu.pl. The CEJSH editorial office will be provided with information on the authors' affiliation as well as their email addresses.
- The editorial office accepts for publication texts in English, concerning broadly understood issues of public law, as well as theory and philosophy of law, social norms, the origin of law and effectiveness of law, written by representatives of disciplines such as law, sociology, economics, management sciences, and political sciences. The submitted texts in English cannot exceed 20,000 characters counted with spaces, the abstracts in Polish and English, the title in Polish and the keywords (about 10 pages of a standard typescript).
- The editorial office reserves the right to make abbreviations, stylistic, linguistic and punctuation corrections as well as to introduce subheadings.
- Unsolicited materials are not returned by the editorial office.
- The authors are requested to provide their addresses (including e-mail addresses) and telephone numbers as well as their academic title, position or function.
- By submitting a text to the editorial office the author transfers to the publisher free exclusive publication rights (copyright and publishing rights), which will be confirmed by a relevant agreement.
- The editorial office informs that ghostwriting and guest authorship are manifestations of scientific misconduct all detected cases will be documented and the relevant entities (the institutions employing the authors, scientific societies, associations of scientific editors, etc.) shall be notified. Ghostwriting occurs when someone has made a significant contribution to the publication without disclosing his or her participation as one of the authors or without mentioning his or her role in the acknowledgments contained in the publication. Guest authorship occurs when the author's participation is negligible or has not taken place at all, yet he or she is the author or co-author of the publication.
- All articles published in the "Public Law Review" are reviewed.
