#### Please give us some brief background on MedVet.

#### What problems did you encounter that led to you using Ovid Discovery?

Historically, we had individual journal subscriptions that were accessible through individual links. This meant that our clinicians may have been missing relevant information or if they found something relevant in a search engine, they would still have to find and visit an individual journal's webpage to access the full text. They couldn't search and navigate to available resources on one page; they always needed to have two windows open.

As part of our commitment to workplace wellbeing, we wanted to expand our educational resources and make them easier to access. How has OVID Discovery helped to address these problems?

It has allowed us to house our resources in a way that makes them accessible from anywhere on any device. With Ovid Discovery, we now have a platform with advanced search capabilities that houses all of our digital resources and provides immediate full-text access to our subscriptions and open-access journals.
