# Tax technology innovation for systems and controls

For more than 200 years, Australia Post has fulfilled its role as the country's leading logistics and integrated services business. Australia Post is a Government Business Enterprise and a self-funded business with commercial and community service obligations.

Each year, it makes a direct contribution of over \$3 billion to national GDP through its operations and in 2020, it contributed \$501.6 million in Government taxes, duties and dividends. As noted in the Australia Post Tax Transparency Report, it abides by its Tax Governance Policy to provide full and transparent compliance with all taxation obligations. In July 2020, it implemented CCH Integrator to support its income tax reporting and compliance needs.

# **Challenge:**

### Streamlining income tax compliance and reporting

The nine-person tax team at Australia Post is responsible for the income tax reporting and compliance for multiple enterprise entities. It had been previously relying on macro-enabled spreadsheets and a web-based tax software to produce its income tax returns and tax related financial reporting disclosures. However, the team needed a more streamlined and integrated solution to deliver a more robust end-to-end process.

Australia Post wanted to streamline its income tax reporting and compliance – from financial reports to tax returns - across all its divisions. This would see CCH Integrator replace the manual roll-forward processes it previously needed to complete for tax provisioning. CCH Integrator would also remove the need to copy and reconfigure data from spreadsheets and its previous tax software into a tax return format.

# CCH Integrator transforms the tax review process and outcome

Australia Post completed a market review to shortlist a solution that was reliable and cost-effective to use. CCH Integrator was selected because of its track record as a global, proven solution. Even though it is in what it considers the early stages of its CCH Integrator implementation, Australia Post believes it has achieved a new economy of scale for review processes.

"Management review process times have reduced by around the 25 – 30 per cent mark," outlined Alesha.

Australia Post can now produce the responses it needs from the system to meet a range of tax queries. Reports are more easily produced and are much 'cleaner' to read, making it even easier to compare year-on-year results and underpin its governance requirements.

Gone are the days where Australia Post's tax team are required to edit Excel spreadsheets in different formats each year. Now the team can utilise the integrity of the CCH Integrator platform to gain a clear view of the underlying tax data. Mapping from the financial information within Australia Post's ERP systems to the annual company tax return is fully transparent, which meets the Australian Taxation Office's reporting standards, and will assist Australia Post in achieving assurance with the Australian Taxation Office through the evidence-based framework of Justified Trust.
