## Nursing Continuing Education Requirement and Use of UpToDate State Licensing Board Regulations

Updated March 2023

Information contained in this spreadsheet is based on publicly available information. It is the licensee's responsibility to ensure their continuing education credits are relevant to their professional growth. Individual licensees are responsible for confirming and ensuring that UpToDate may be accepted to fulfill nursing requirements. Licensees are supposed to engage in continuing education activities that provide professional growth and that are relevant to their professional practice. UpToDate cannot determine if credits/hours earned using UpToDate are relevant to each licensee, therefore UpToDate cannot guarantee acceptance of all credits for all licensees.

North Dakota				х	The North Dakota Board of Nursing does not accept UpToDate contact hours for pharmacology-specific continuing education for prescribing authority. Accessing of UpToDate resources does not meet continuing education contact hour requirements set forth in ND law and rules.
<u>Ohio</u>		x			AMA CME credits may meet the CE requirements for nurses. Ohio Board of Nursing confirmed that AMA CME credits from UpToDate would convert 1:1 to "Contact Hours" for nurses in Ohio. AANP and Time-based tracking <b>do not</b> qualify.
<u>Oklahoma</u>			х		Licensees must demonstrates evidence of meeting continuing qualifications for practice through meeting certain requirements such as the completion of at least 24 contact hours of continuing education applicable to nursing practice.
<u>Oregon</u>				х	For nurses who have 400 hours of practice within two years of their renewal application, the continuing education requirements are limited to cultural competency and pain management. UpToDate cannot satisfy these requirements.
<u>Pennsylvania</u>		x	х		Both AMA CME credits and AANP contact hours may be accepted towards CE requirements. Content needs need to meet the requirements in Section 21.133 pertaining to continuing education content in order to count towards the required credits.

<u>Utah</u>		х	х		Both AMA CME credits and AANP contact hours may be accepted towards CE requirements. All required CEs must be relevant to the nursing profession.

Washington D.C.		х				AMA CME credits may meet the CE requirements for nurses. 1 AMA CME credit can be converted to 60 minutes or 1 contact hour (0.1 CEU)
<u>Washington</u>			x	x		UpToDate may be used toward requirements. If audited, nurses must provide documentation and certificates/logs from UpToDate would suffice.  Requirements are in hours, so nurses should use AANP or time-based tracking setting. It is up to the individual nurse to determine whether reading UpToDate pertains to their nursing practice and areas of interest.
West Virginia			х			AANP contact hours may be accepted towards CE requirement. Topics must meet the Board's requirements. See Board statutes for details.
Wisconsin	х					Wisconsin does not require continuing education for nursing license renewal.
Wyoming		х	х			Wyoming does not require continuing education for license renewal but has a competency option (earning CE hours is one option for RN/LPN renewal). CE is required for CNA and APRN renewal. Both AMA CME credits and AANP contact hours may be accepted towards CE requirements.
