

Forming new entity?

- Obtain State IDs
- Appoint Registered Agent
- · Conduct Name Availability Check
- File Name Reservation/Registration
- File Articles of Incorporation (Corp.) or Articles of Organization (LLC)
- Apply for Business Licenses and Permits
- File Assumed Name or DBA Certificate
- · File for Trademark Protection (if desirable)
- Apply for Employer identification Number (from IRS)
- · Order Corporate Records Kit
- · Domain Registration (if needed)
- Publication in newspaper (if required by state)

Terminating an entity?

- · File Articles of Dissolution
- Obtain Tax Clearance Letter (if required)
- File Notice of Intent to Dissolve (if required)
- File Withdrawal of Qualification/Registration AND/OR Evidence of Dissolution or Merger (for each foreign state)
- · Cancel Business Licenses and Permits
- · File Evidence of Dissolution or Merger
- Cancel Assumed Name or DBA Certificate

Complying with ongoing responsibilities?

- · File Annual Report
- File and Pay Franchise Tax
- · File Federal and State Tax Returns
- Renew Business Licenses & Permits
- Renew Assumed Name or DBA Registration
- Independent Director and Corporate Staffing (if needed)

Changing entity structure?

- · Conduct Name Availability Check (if changing name)
- File Name Reservation/Registration (Corp.) or Articles of Organization (LLC)
- File Application for Conversion (if changing entity type)

Changing Registered Agent?

File Notice of Change of Registered Agent

Proving Corporate Existence for Business Transactions?

- · Obtain Certificate of Good standing
- Obtain Apostille (if required for foreign country transactions)
- · Obtain Certified Copy of Formation Documents

Expanding Business to Another State or Country? (Foreign Qualification)

- Obtain State Tax IDs
- Conduct Name Availability Check
- · File Name Reservation/Registration
- File Foreign Qualification/Registration
- File Assumed Name or DBA Certificate
- Apply for Business Licenses and Permits
- · Appoint Registered Agent in Foreign State
- · International Filing and Document Retrieval
- · Obtain Certificate of Good Standing from Home State

Merging/Acquiring Another Business? (Survivor Filings)

- · Conduct Name Availability Check
- File Name Reservation (if name is being changed)
- File Amendment of Assumed Name or DBA (if needed)
- File Foreign Qualification Documents (see above)
- File Evidence of Merger (in foreign states, if required)
